### **Job Description: Childhood Practitioner Role:**

To support and assist in the provision of care to the highest quality in a holistic setting for children.

### **Duties and Responsibilities**

- Be willing to work with children of various ages from wobblers to afterschool children
- Perform a variety of tasks, such as nappy changing, toileting, sterilising, feeding, nap supervision and engaging in play.
- Conduct observations of children under the direction of management
- Always follow the policies and procedures of the service
- Cleaning, tidying and storage of equipment and toys after use
- Co-ordinate the implementation of activities suitable for different age groups
- Maintain room, and equipment, to always ensure the health and safety of children
- Ensure a good standard of hygiene
- Organise materials and toys to the benefit of children
- Support children's developments – emotional, social, physical and cognitive in carrying out activities
- Attend meetings and undergo training as required
- Be aware of child protection procedures and advise manager/DLP should you have any concerns about a child
- Maintain strict confidentiality, any breach of confidentiality about children or their families will constitute gross misconduct
