- A good knowledge and understanding of child protection and the duties and responsibilities under Children First.
- An ability to work in partnership with the team.

- Experience of dealing with challenging behaviours and special needs.
- Experience of working with parents as partners.
- Computer skills- knowledge of word is essential,
